## **Agreement Terms:**

#### The Society agrees to:

- 1. Provide The Venue Hall (or a suitable alternative) for the Performer.
- 2. Pay the Performer in cash after the event (unless otherwise agreed upon).
- 3. Split the total door, online and outlet ticket sales 50/50 with the performer.
- 4. Keep promotional tickets to a minimum
- 5. Set up the hall seating and stage in accordance with the Performer's requirements if any.
- 6. Provide at no cost, the sound system, microphones & stands, lights and sound engineer.
- 7. Supply the warm-up band to help drive ticket sales (unless otherwise agreed upon).
- 8. Promote the Performer's event starting 45 to 60 days in advance of the event, depending on other events running during that time.
- 9. Promotion will include but not necessarily be limited to:
  - a. 25 + color posters distributed to bulletin boards throughout the area.
  - b. Posting on the Chamber of Commerce Electronic Sign Board at 121 Northwest Blvd, Creston, BC
  - c. Posting on Creston Events webpage calendar at http://www.crestonevents.ca/.
  - d. Posting on our Facebook page with lead-up live streaming videos to build excitement and urgency to purchase tickets.
  - e. Paid Facebook advertisements
  - f. Live streaming clips during the event (with permission) for promotion and post-event posting on Facebook and website.
  - g. Email ads to our continually growing email list.
  - h. Your bio on our webpage with links to your webpage and your tour schedule to help you build your branding.
  - i. Podcast interview for release Sunday afternoon during our regular podcast to help promote you.

### The Performer agrees to:

- 1. Arrive at The Venue hall (or alternative) no later than 4:00 P.M. for the podcast recording.
- 2. Be available from 6pm 6:30pm for up close and personal meeting with VIP fans (tell stories, play some accoustics and sign personal items).
- 3. Play from 7:45 P.M. to at least 9:30 P.M. but no later than 10:30 P.M. with a 15 minute intermission.
- 4. Provide one merchandise item (if available) at no charge for a give-a-way draw during your intermission.

Concession sales, food sales, alcohol sales, venue paraphanalia sales; belong to the Society. Performer merchandise sales belong to the Performer.
